### IV. OFFICCER REPORTS

## A. TREASURER: Carrie Lujan, CSU, Monterey Bay

- i. Carrie: Could not make it to the meeting this morning.
- ii. Jesus Clemente reported for Carrie: The current budget amount is \$14,004.44.
- iii. Guille will confirm with Carrie on budget amounts.

### B. PRESIDENT: Gillermina Martinez, CSU, Bakersfield

- i. Last Board Meeting was in Arizona on January 19<sup>th</sup> 2009, Guille was ill and not able to attend.
- ii. Items discussed:
  - I. The board hopes to get the TRiO name out, and is wanting to get in contact with Alumni and utilize them to promote TRiO. The board is asking to please submit the names and contact information of TRiO alumni whom currently hold high roles and positions to Tomasa.
  - II. WESTOP Conference

- iii. Pending items:
  - I. CVENT: asked for assistance but still awaiting for the help, most likely will not get resolved until the WESTOP conference.

## C. VICE PRESIDENT: Ricardo Marmolejo, College of the Sequoias

i. Ricardo: Congratulated those who had just submitted their APR.

- ii. Membership for CEN CAL and WESTOP is being updated daily. If anyone is interested in obtaining this information they can get in contact with Ricardo to receive the link or the list of paid members.
- iii. WESTOP Conference: is coming up, please make an effort to attend March 1<sup>st</sup>-4<sup>th</sup> in Phoenix Arizona.

- i. Welcomed everyone to the meeting and asked members to please take a moment to sign in.
- ii. Thanked the individuals who turned in committee reports, but only received a couple of them. She asked that committee chairs please submit reports before the meeting, this way it makes it easier to record the minutes.

#### V. COMMITTEE REPORTS

## A. LEGISLATION & EDUCATION: (Kimberly Hughes)

- i. Ricardo: Kimberly is absent but sent out a report.
- ii. Ricardo: Read Kimberly's report.
  - I. The senate is now working on it's version of the economic stimulus plan.
  - II. Draft letters have been sent to CenCal members to do their part and intervene by contacting your Congressmen in advance on behalf of TRiO programs.
  - III. The House decided to postpone a vote on the "omnibus" appropriations bill for the FY 2009. The current extension is in place until March 6<sup>th</sup>, 2009.
  - IV. The FY 2010 budget cycle begins this month.
  - V. COE Policy Seminar is March 22<sup>nd</sup>-24<sup>th</sup>, 2009. The focus will be on the stimulus plan.
  - VI. Upcoming Competitions: SSS Spring/Summer 2009; ETS and EOC in Fall 2009; UB Summer 2010; and McNair summer 2011.
- iii. Guille: Clarified the safe practices of lobbying.
- iv. Guille: Will need a volunteer to attend policy seminar, hopefully President Elect will be able to.

### B. SUMMER JAM: Arnold, CSU, Monterey Bay

i. Arnold: Distributed copy of report.

- **I.** Does not have a full committee in place, all the planning so far has been done in house (NHU).
- **II.** Dates have been reserved as well as the facilities.
- **III.**Guest speakers have been reserved.
- **IV.** Attached to the report are hotel rates in the area.
- **V.** Need to confirm the total number of participants- estimates have been done to a total of 150-200 participants.
- VI. Food prices included.
- VII. Has included two agendas for those programs that cannot stay overnight.
- ii. Arnold: Asking for suggestions and/or changes.
  - I. Martina: \$30 per student is a little high. What has been done in the past years is that programs are allowed to bring up to 50 students and pay a set amount that has been max \$600, suggests revisiting and designating a set amount per program.
    - **a.** Arnold: Will consider but thinks that will also depend on number programs that will commit by April 3<sup>rd</sup>.
    - **b.** Rey: Suggests having them send a list of participants once they commit.

### C. PDS: Gillermina Martinez, CSU, Bakersfield

- i. Gillermina: Two workshops have been locked in but wants to step out of today's meeting with a location.
  - I. Options are Chuckchansi or Hollywood. Guille wants to choose a location where getting to the location is not a problem or a huge expense.
    - a. Jessi: Suggests we stay within our Colleges and Universities.
    - b. Rey: Suggests we speak to Guille now and let her know want we want and expect.
    - c. Arnold: Wants to know some of the reasons why certain programs could not come to PDS last year.
      - Wendy: No real reason were given to her but suggests to be conducted on a University Campus.
    - d. Rey: Fresno would be a more central location.
    - e. Dave Ferguson: Would hate to see the chapter limit themselves to attend professional development, it is something you work out now with your supervisor to try to attend. PDS is usually the highest revenue event of the chapter. PDS' were developed to get everyone to attend especially for those that were not able to attend the WESTOP.
    - f. Ginna: We have to be flexible, something we teach our programs. This is just a bad year because of the economy

- and maybe this year it can be different, make it a one-day event
- g. Jessi: It would be difficult to justify Hollywood and would really like to stay within Central Califorina.
- h. Rey: Who is able to host us in their college?
- i. Jenny A.: Normally the event is 3 days, we can cut down to 2 and can make it easier for some to attend and it is easier to justify going out to a campus vs. a casino.
- j. Jenny R.: Fresno throws out the name in the pot.
- k. Ben: Suggests Monterey Bay.
- 1. Wendy: Coming out of Kona there was 100 people in the roster and people just did not respond which was very frustrating, we have to commit.
- m. Guille: Will take Fresno State and Monterey Bay in consideration.
- II. Guille: PDS dates are set for Oct. 7<sup>th</sup>-9<sup>th</sup>, 2009.

### D. SLC: Rey CSU, Bakersfield

- i. Rey handed out copies of committee report:
  - I. It was cancelled but kept in communication with those programs attending although forgot to let their committee members and were still working hard.
  - II. Norma: Scholarships are presented during this event, any suggestions as to when they can be presented?
    - a. Rey: This would be an item for the scholarship committee to discuss.

### E. TRiO Day: Jolisa Espinoza, San Jose State

- i. Guille: Jolisa is not present but sent in her report.
  - I. Due to the lack of Nor Cal representation and due to a holiday it has been tentatively postponed.
  - II. Looking at doing a state wide event to combine WESTOP chapters.
  - III. Looking for all chapters to agree on a date, and will send t-shirts to all participants to wear while giving back to the community.
    - a. Ricardo: Would this require all chapters to get together?
    - b. Guille: Every institution would be going out and do a type of community service in their community.
    - c. Cindy Dunn: Suggests doing Habitat for humanity to gain greater attention.
    - d. Arnold: Suggests Cesar Chavez day since it symbolizes day of service.
    - e. Guille: Asks to please send your suggestions to Guille or Jolisa.

## F. SCHOLARSHIPS: Jesus Clemente, CSU, Monterey Bay

- i. Jesus: Final count of submitted scholarships were 36, 8 came from UB program at Fresno State, 16 were from ETS programs, and 12 from SSS programs.
- ii. The scholarship committee will meet again on the 24<sup>th</sup> of February at Fresno State to continue to review applications. All of the SSS applications were reviewed today, but will also make final decisions on the winners on the 24<sup>th</sup>.
- iii. Looking at awarding 8 students at the amount of \$500, subject to change.

### G. COMMUNICATIONS: Ben Reynoso, CSU, Fresno

- i. Ben: Currently in the process of adding an information sheet on the web for the new members to fill out.
- ii. Once scholarship recipients are selected he would like to post their information on our website.
- iii. Would like to get an idea of how many CenCal members are planning on to attend the WESTOP Conference in Phoenix?
  - I. Of all members present (39) six said they would be attending.
  - II. Ben asked if someone can take pictures during the conference and email to him to post on the website.

### H. HISTORIAN: Dennis Adkins, Fresno City College

- i. Dennis: Last meeting in SJS he was able to grasp some of insights and observations of how the CenCal chapter came about. He wrote up a premise, passed out copies and asked that we give him feedback.
